

## INVITATION FOR BID

Separate sealed bids for surface rehabilitation of portions of **Deer Lodge 2020 Street Maintenance** in Deer Lodge, Montana will be received by the City of Deer Lodge, in the City Council Chambers in City Hall, 300 Main Street, Deer Lodge, MT, 59722. Sealed bids will be publicly opened and read aloud on July 9 at 2:00 PM local time.

The Project generally consists of:

Asphalt tack coat, crack sealing, and chip sealing of Prairie Avenue, Tumbleweed Lane, Sagebrush Lane, Buckskin Drive, Maryland Avenue, and 5<sup>th</sup> Street. Additionally, curb and gutter are to be installed at the Maryland/Dixon intersection, and two 2 slotted manholes are to be installed at the intersection of Tumbleweed Lane and Buckskin Drive. Approximate quantities for major work items are: 14,300 LF crack seal, 25,500 SY asphalt seal coat (chip seal), 500 LF curb and gutter, 2910 SF paving, 14500 SF of concrete approaches/HC ramps and 3060 SF of asphalt demo and disposal.

The contract documents consisting of the Project Manual may be examined or obtained at the office of Stahly Engineering and Associates, Inc. and at City Hall in Deer Lodge, in accordance with Article 2.01 of Instructions To Bidders. Required deposit is \$50.00 per set, which is not refundable. Express mail will require an additional \$20.00.

In addition, the Drawings and Project Manual may also be examined at Montana Plans Exchanges via Montanabid.com. A Pre-Bid Conference will be held at 1:00 on Tuesday, June 30, at City Hall in Deer Lodge. Attendance is encouraged.

Contractor and any of the contractor's subcontractors bidding or doing work on this project will be required to be registered with the Montana Department of Labor and Industry (DLI). Forms for registration are available from the Department of Labor and Industry, P.O. Box 8011, 1805 Prospect, Helena, Montana 59604-8011. Information on registration can be obtained by calling 1-406-444-7734. All laborers and mechanics employed by contractor or subcontractors in performance of the construction work shall be paid wages according to Montana Prevailing Wage Rates for Highway Construction. The contractor must ensure that employees and applicants for employment are not discriminated against because of their race, color, religion, sex or national origin.

Each bid or proposal must be accompanied by a Certified Check, Cashier's Check, or Bid Bond payable to the City of Deer Lodge, in an amount not less than ten percent (10%) of the total amount of the bid. Successful bidders shall furnish an approved Performance Bond and a Labor and Materials Payment Bond, each in the amount of one hundred percent (100%) of the contract amount. Insurance as required shall be provided by the successful bidder(s) and a certificate(s) of that insurance shall be provided and the City of Deer Lodge listed as additional insured.

The City reserves the right to reject any or all proposals received, to waive informalities, to postpone the award of the contract for a period of not to exceed sixty (60) days, and to accept the lowest responsive and responsible bid which is in the best interest of the OWNER.
