#### 4. County Health Report.....Ida Miller

Powell County Public Health continues to offer Child Safety Seat inspections. They also have some child safety seats available on a sliding scale fee basis. Montana State Prison has not reported a positive case of Covid in staff or offenders since February 4<sup>th</sup>.

**Home test kits** are available thru Powell County Public Health. Call if you need one, they are good until July 2022. If used and positive, there are directions included on how to report the test or call Public Health staff for assistance. The advantage of using and reporting of home test results is that there is a verified record of the positive case and then if a positive test result is received in the next 90 days it does not delay further events such as travel or surgery.

**Travel restrictions** for Covid-19 are constantly changing. Check with Public Health if you are travelling out of the country. Canada and Hawaii have recently updated their travel information.

**Vaccinations** are still available, and the CDC is recommending another booster for anyone age 50 and over if you have received the recommended previous vaccinations. Powell County ranks ninth in state for fully vaccinated eligible Montanans.

**Testing** and contact tracing for Coronavirus continues in Powell County. In March, there were 5 positive cases in Powell County that were reported thru the State network. Home testing has been very active but reporting of home tests has been very low. Reported hospitalizations due to Covid-19 for the month of March were zero.

The main variant tested in Montana now is BA.2 which is named Delta Cron. The most prevalent Delta Cron symptoms as reported are:

- 1. Headaches
- 2. High fever and subsequent sweating or chills
- 3. Sore throat
- 4. Persistent cough
- 5. Unexplained fatigue or loss of energy
- 6. Chronic, widespread body pains and aches

#### b. Rural Fire District Contract - Jordan

Presented the proposed amended Rural Fire District Agreement. The first change paragraph two says this entire agreement supersedes all prior agreements. This agreement will for four years, which is lowered from the 10-year agreement. Section nine is the section that talks about the review period that will happen every two years, we'll look at things like what equipment has been transferred, what the property values are, if the percentage that the rural fire department changes that'll be reviewed every two years to see if there's changes that needs to be made. The bulk of the changes in paragraph eight, duty, and obligations of the rural fire districts. The Rural Fire District will be obligated to pay an annual contract payment in two equal installments. The formula by which the annual contract payment shall be calculated is the percentage of the total taxable value between the city and the county.

The contract also includes that \$5,000 equipment credit to continue to be applied, which is deducted from the annual contract payments. All vehicles and equipment conveyed to the city shall become the exclusive property of the city of Deer Lodge. Paragraph nine includes language concerning that that two-year review talking about how the taxable values will be calculated every two years and that the review should occur before July 1, the beginning of the fiscal year for that year. Paragraph 11 contains an additional clause that any amendments to this agreement will be attached as an addendum to this agreement instead of changing this original agreement.

Member Kersch motioned to approve and recommend to Council as presented. Member Fjelstad seconded the motion. 3 Ayes, 0 Nos. Motion passed.

#### Important Public Health concerns other than coronavirus:

Powell County Public Health Officer: Dr. Paul Rees

Dog bites: Seem to become more prevalent when the weather is warm.

**Rabies**: As more wildlife becomes active as the weather warms, caution should be taken to prevent potential exposure.

Rabies is a fatal but preventable viral disease. It can spread to people and pets if they are bitten or scratched by a rabid animal. In the United States, rabies is mostly found in wild animals like bats, raccoons, skunks, and foxes. However, in many other countries dogs still carry rabies, and most rabies deaths in people around the world are caused by dog bites.

**Ticks**: Different species carry different types of disease, in Montana the main species of tick we worry about are the black-legged tick or deer tick and the American dog tick. Those are the ones that carry diseases of the most concern to us right now, including Lyme disease which only deer ticks carry, and Rocky Mountain spotted fever which is carried by the dog tick.

**Hantavirus:** With spring weather, cleaning of outbuildings which may harbor rodents can lead to potential for exposure to hantavirus. Appropriate precautions should be used when evidence of rodents is visible. The most important hantavirus in the United States that can cause Hantavirus Pulmonary Syndrome is spread by the deer mouse here in Montana.

**Highly Pathogenic Avian Influenza:** There has been one human infection in Colorado. There are flocks and wild bird infections in Montana. This virus is extremely infectious and fatal to poultry and some species of wild birds. Although risk to humans is very low, Montanans should take precautions when handling game birds or any sick or dead bird they find. Gloves should always be worn when handling game birds or any sick or dead bird that must be handled for disposal. People are encouraged to report unusual or unexplained cases of sickness and/or death of domestic or wild birds by calling code enforcement at 406-594-0911 or public health at 406-691-0242.
